**① Proof of Identity Document (valid and unexpired)**

Each of the following must state the applicant's legal name and date of birth.

- A U.S. passport (if you have obtained or renewed your passport within the last 6 months, please bring an additional Identity Document)
- A certified copy of a birth certificate
- A Consular Report of Birth Abroad (CRBA)
- A Permanent Resident Card
- An Employment Authorization Document (EAD)
- A foreign passport with a valid US visa and approved I-94 form documenting most recent admittance into the US
- A Certificate of Naturalization
- A Certificate of Citizenship
- Proof of a change to the name, if necessary

**② Proof of Residency Documents**

P.O. Box addresses will not be accepted.

Each of the following must state the address of residence in the applicant's name unless otherwise stated.

- A utility bill (gas, electric, telephone, cable, oil, water, sewer, satellite, heat, cell phone) from the past 60 days (can be in an immediate family member's name)
- A personal check or bank statement from the past 60 days
- A payroll check from the past 60 days
- A non-handwritten lease agreement currently in effect with the landlord's name, address, and telephone number.
- A letter issued by a Rhode Island state agency or a federal agency approving receipt of benefits from an entitlement program from the past 60 days
- A homeowner's or renter's insurance policy
- An automobile insurance policy
- A property tax bill from the previous year
- A letter from a Rhode Island shelter or halfway house on letter head, dated in the past 30 days, with the name and contact information of an administrator
- A jury duty summons from the past 60 days
- A W-2 form from the previous year
- An installment loan contract (automobile, student loan) that is currently in effect
- A current Social Security Administration statement
- A Rhode Island-issued firearms permit that is currently in effect
- A valid Rhode Island driver's license or identification card

**① Proof of a Social Security Number Document**

Each of the following must state the applicant's full name and Social Security Number unless otherwise stated.

- An official Social Security Card (can be laminated)
- A letter issued by the Social Security Administration that the applicant is not eligible to receive a Social Security Number
- A W-2 form from the last 5 years
- A 1099 form from the last 5 years
- A paystub from the last 5 years

**REAL AND NON-REAL ID LICENSE and ID CARDS: ADDITIONAL DOCUMENTS**

These documents are required on top of a completed LI-1 form and the documents listed above.

**If the applicant is a minor:**

- A school record from the current school year (report card, diploma, transcript, or ID) or past year if during the summer, OR
- The Rhode Island driver's license or ID card of the individual signing the minor's application.

**If applying for a name change:**

- Social Security Card (not a copy) or notice with your updated name (must wait 24 hours for name change to register with the Social Security Administration)
- Current RI license or identification card
- Original government issued document indicating name change (e.g. Marriage Certificate, Divorce Decree)

**If applying for a new permit:**

- Driver Education Certificate (if under 18)
- If your driving certificate has not been approved by CCRI, you must take the knowledge exam test.

**If applying for an Out-of-State Transfer:**

- Your current license from the other state
- If the out-of-state license is not available at time of transfer you must submit a driving record or verification from the other state with an Identity Document (see above.)
- All license transfers are only done at the DMV Cranston Headquarters.

**If applying for an Address Change:**

- Current RI license or Identification card

**If applying for a Gender Change:**

- Gender Designation form
- Current RI license or identification card

**If applying for a Motorcycle permit or license:**

- Current RI license or Identification card
- If applying for permit: certification of completion from the RI Motorcycle Safety course
- If applying for license: valid motorcycle permit
